# LIQUOR LICENCE BY-LAW

# INDEX

#### 1 Definitions and interpretation.

In these regulations, unless the context otherwise indicates, a word or

expression to which a meaning has been assigned in the Act has that meaning.

"Agricultural area" means an area predominantly zoned for agriculture or any other equivalent zoning, with the purpose to promote and protect agricultural activity on a farm as an important economic, environmental and cultural resource, where limited provision is made for non-agricultural uses to provide owners with an opportunity to increase the economic potential of their properties, without causing a significant negative impact on the primary agricultural resource;

"Authorised official" means a delegated employee of the Municipality's; Safety and Security, Liquor Enforcement and Compliance Unit and includes any other authorised official delegated to enforce the provisions of this by-law;

"Business premises" means a property from which business is conducted and may include a restaurant, pub, bar or tavern or other building for similar uses, but excludes a place of entertainment, guest accommodation establishment, Nature Reserves, Recreational parks, dams, sports and community club;

"Municipality" means Dr JS Moroka Local Municipality, a municipality established In terms of the Local Government: Municipal Structures Act, 1998, or any structure.

"Compliance notice" means a written instruction of an authorised official as contemplated in Mpumalanga liquor Act 5 of 2006

"Council" means the Municipal Council of the Dr JS Moroka;

"general business area" means an area predominantly zoned general business or any other equivalent zoning, with the purpose to promote economic activity in a business district and development corridor, and includes a wide range of land uses such as business, residential and community uses;

"guest accommodation establishment" means premises used as temporary residential accommodation, and includes the provision of meals for transient guests for compensation and includes Lodges, a bed-andbreakfast establishment, guest house, as well as facilities for business meetings, conferences, events or training sessions of resident guests.

"industrial area" means an area predominantly zoned general industry or any other equivalent zoning, with the purpose to accommodate all forms of industry including manufacturing and related processing, but excludes noxious or hazardous risk activity;

"Licensee" means a person who is licensed to sell liquor in terms of the Act and includes the manager who is responsible for the management of the business and is subject to the same duties, obligations and liabilities as the licensee;

"Liquor" means liquor as defined in the Act;

"local business or neighbourhood business area" means an area predominantly zoned local business or mixed use or any other equivalent zoning with the purpose to

accommodate low intensity commercial and mixed use development serving local needs of a convenience goods, personal service or small scale business nature or serve as an interface between general business, industrial and adjacent residential areas;

**"off-consumption premises"** means the place of business from which a licensee sells liquor to be consumed at a location removed from the place of business;

"on-consumption premises" means the place of business and location in which liquor is sold and consumed;

"Organised function" means a celebration, party or similar festivity shared at a licensed premises;

"Person" means a natural person or a juristic person;

"place of entertainment" means a place used predominantly for commercial entertainment which may attract relatively large numbers of people, operate outside standard business hours or generate noise from amplified or live music or revelry on a regular basis, and includes a cinema, theatre, amusement park, dance hall, gymnasium, or facility for betting, gambling hall, karaoke bar and nightclub, but excludes a casino;

**"residential area"** means an area predominantly zoned informal, single or general residential or any other equivalent zoning, with the purpose to

accommodate predominantly single-family dwelling houses in low to medium density neighbourhoods, as well as higher density living accommodation and which includes controlled opportunities for home employment, additional dwellings and low intensity mixed use development;

# "Sell" includes -

- (a) To supply, exchange, offer for sale, display for the purpose of sale; or
- (b) To authorise, direct or allow a sale, supply, exchange, and offer for sale or display for

Sale; for the exchange of money or any other type of consideration; "sale" And "sold" have corresponding meanings;

**"small holding or rural area"** means an area predominantly zoned rural or any other equivalent zoning, with the purpose to accommodate smaller rural properties that may be used for agricultural purposes, but may also be used primarily as places of residence in a more country or rural setting;

**"sports and community club"** means premises or a facility used for the gathering of community or civic organisations or associations, sports clubs or other social or recreation clubs run mostly not for-profit and may include community service clubs and community centres or similar amenity facilities, but excludes a night club;

**"standard trading"** means trading days and trading hours as contemplated in sections 4 and 5 of this By-law, and excludes extended trading days and hours that may be approved by the Municipality in terms of section 6 of this By-law;

"suspension notice" means a written notice to suspend extended liquor trading days and hours as contemplated in section 8;

**"Sub-council"** means a political substructure of Council which has been delegated with certain powers and duties of Council;

"The Act" means the Mpumalanga Liquor Licensing Act, (Act No. 5 of 2006);

**"Zoned"** means zoned as the case may be in terms of the NDM Zoning Scheme Regulations; and "zoning" has a corresponding meaning.

## 1. **PREAMBLE**

# WHEREAS

The Dr JS Moroka Local Municipality as the local authority regulates formal and informal trading;

Whereas Section 156 of the Constitution of the Republic of South Africa ,1996 (Act No. 108 of 1996) read in conjunction with section 12 and 13 of the Local Government: Municipal Systems Act,2000 (Act No. 32 of 2000) as amended;

Therefore be it enacted as follows:

# 2. APPLICATION OF THE ACT

**2.(1)** This By-law is applicable to licensees that sell liquor to the public within the jurisdiction of the Municipality.

# 3. EFFECT AND EREVIEW

3.1 The by-law will take effect on the date on which it is published on the Government Gazette and be reviewed upon the election of new Council or on the change in legislation.

# 4. General Prohibition

- 4.(1) No person may sell liquor to the public for on consumption or off consumption
  - (a) Outside of the days and hours that have been determined by the Municipality; and
  - (b) Without valid liquor licence that has been issued as contemplated in the Act.
  - (c) The person who is doing business inspection must have identification.

# **5. OBJECTIVES**

5.1 To control , regulate and co -ordinate the business trading licence by the Liquor licence board.

# 6.. Incentive scheme

6.(1) No liquor licence application fee as contemplated in section 35(9) of the Act, is payable by

an applicant who duly applies for the first time for a liquor licence in terms of this Act: Provided that, in the instance that an applicant simultaneously applies for the first time for more than one liquor licence,

such applicant is exempted from the payment of only the highest liquor licence application fee being applied for.

- 5.(2) No liquor licence renewal fee as contemplated in section 38(1)(c) of the Act is payable by an applicant as contemplated in sub regulation (1) in respect of the first subsequent renewal of such liquor licence issued in terms of the Act in respect of which an exemption as contemplated in sub regulation (1), has been granted.
- 5.(3) In respect of the second and all subsequent liquor licence renewals of a liquor licence in respect of which an exemption as contemplated in sub regulation (1) has been granted, an applicant contemplated in sub regulation (1) is responsible for the payment of the full applicable liquor licence renewal fee.
- 5.(4) The categories of applicants listed in Annexure 5 may, in terms of section 35(9) of the Act apply and motivate, in writing, to the Authority, for exemption from the payment of the costs or the payment of reduced costs, associated with applying for a liquor licence or a specified category of licence, in terms of the Act.

## 6. Form of application, certificates and other documents

6. (1) Every application required to be made, and every certificate or other document required to be issued in an approved form in terms of these regulations, must be issued in the form contained in these regulations and must be duly sworn or affirmed to before a duly appointed Commissioner of Oaths as contemplated in the Justices of the Peace and Commissioners of Oaths Act, 1963 (Act No.16 of 1963).

6. (2) The Authority must, at the request of a person who wishes to apply for a licence in terms of these regulations, furnish that person with the appropriate application form and applicable requirements of a licence and such other assistance as may be necessary to duly apply for a licence.

# 7. Application for a liquor licence.

- 7.(1) An application in terms of section 35 of the Act for the application of a liquor licence must be made in the form as set out in Annexure 1 to the Schedule and must be accompanied by all documents specified in such form, including the non -refundable application fee as set out in Annexure 4 to the Schedule.
- 7. (2) An application for a liquor licence must be accompanied by comments of the Municipality within which area of jurisdiction the premises of the business in respect of which the application is made, is situated, as set out in Annexure 3 to the Schedule.
- 7. (3) An application for a liquor licence must further be accompanied by the non refundable fee as stated in Annexure 4 of the schedule, which may be changed from time to time by the Member of Executive Council by notice in the Provincial Gazette.
- 7. (4) The Authority may exempt an applicant from any costs related to the application of a licence upon the receipt of an application for exemption on the form set out in Annexure to 5 to the schedule.
- 7. (5) On approval of an application for a liquor licence, the Authority must duly register such a

licence and must subsequently issue to the applicant a licence certificate made in the form as set out in Annexure 6 to the Schedule.

#### 8. Renewal of a Liquor licence.

8.(1) An application for the renewal of a licence shall be made to the Authority on the form set out in Annexure 7 to the Schedule.

- 8.(2) An application contemplated in subregulation (1) shall be made not less than 90 days before the date on which the licence concerned shall lapse, and be accompanied by the non- refundable renewal fee stated in Annexure 4 to the Schedule, which fee may be changed from time to time by the Member of Executive Council by notice in the Provincial Gazette.
- 8. (3) If an application for the renewal of a licence is made less than 90 days before the date on which the licence concerned shall lapse, the Authority may require the applicant to pay, in addition to the non -refundable fee stated in Annexure 4 to the Schedule, an additional fee stated in Annexure 4 to the Schedule, prior to considering such application.
- (4) On approval of an application for a liquor licence, the Authority must duly register such a licence and must subsequently issue to the applicant a licence certificate made in the form as set out in Annexure 7 to the Schedule.

#### 9. Keeping of records by a licenced person.

- 9.(1). As contemplated in section 39(4) of the Act, a licenced person must keep and maintain records of a licenced business pertaining to -
- (a) All licence certificates and conditions of each;
- (b) Annual renewal forms;
- (c) All managers certificates for managers appointed in terms of regulation 10(2);
- (d) Records of each and every employee;
- (e) Copy of approved sketch plan of business premises;
- (f) Records of each and every single sale of R2 500,00 or more.

# 10. Voluntary cancellation of licence.

10.(1) A licenced person may, at any time, requests the Authority to cancel his, her or its licence with effect from a specified date by use of a request form as set out in Annexure B to the Schedule. 10. (2) The Authority shall upon receipt of such a request inform the person requesting voluntary cancellation of its decision and provide written reasons thereof on a form as set out in Annexure 9 to the Schedule.

#### 11. Change of controlling interest.

- 11.(1) A licenced person shall not permit any other person to procure a controlling interest in the business to which the licence relates.
- 11. (2) A licenced person may, at any time, together with a person eligible for a liquor licence intending to procure interest in a licenced business, make an application as set out in Annexure 10 to the Schedule.

# 12. Transfer of licence.

- 12.(1) A licenced person may at any time transfer his, her or its licence to another undisqualified person by making an application together with such new prospective holder of the licence concerned as set out in Annexure 11 to the Schedule.
- 12. (2) an application in (1) shall be accompanied by -
- (a) a copy of an advertisement inviting public comments in a local newspaper and the Provincial Gazette;
- (b) comments from the local municipality;
- (c) an application fee for the transfer of a licence, as set out in regulation 4.

#### 13. Management of business.

- 13.(1) A person other than a natural person shall not conduct any business under a licence unless a natural person who is not disqualified from being a licenced person, is appointed by that person to manage and be responsible for the business to which such licence relates as set out in Annexure 12 to the Schedule.
- 13. (2) A natural person who is a licenced person may appoint another natural person who is not disqualified from being a licenced person, to manage and be

responsible for the business to which such licence relates as set out in Annexure 13 to the Schedule.

# 14. Trading hours.

14. (1) The Authority shall, when issuing a licence under this Act, restrict the days and hours during which a licenced person may sell liquor in terms of such a licence, in accordance with the recommendations made by the Municipality concerned subject to the requirements as set out in Annexure 14 to the Schedule.

#### 15. Summons to appear

15.(1)The Authority may cause any person to personally appear before it for purposes of giving evidence or producing a document or a thing, by means of a summons in the form as set out in Annexure 15 to the Schedule.

#### 16. Appeals and reviews.

16.(1) Any person whose rights or legitimate expectations have materially and adversely been affected by a decision of the Authority may, within 20 days of being informed of such decision, appeal to the Member of the Executive Council, in writing, as set out in Annexure 16 to the Schedule.

#### 17.Offences

- 17.1 . Any person who
  - (a) contravenes or fails to comply with any provision of this By-law; ignores, disregards or disobeys any notice, sign or marking displayed or erected in terms of this By-law;
  - (b) contravenes or fails to comply with any approval granted or condition imposed in terms of this By-law;
  - fails to comply with a lawful written instruction by the municipality to move or remove his or her property;
  - (d) deliberately furnishes false or misleading information to an officer or an employee of the municipality; or
    - a. threatens, resists interferes with or obstructs an officer or employee of the Municipality in the performance of his or

her powers, duties or functions under this By-law, shall be guilty of an offence.

# **18.** Penalties

18.1 Any person guilty of an offence in terms of this By-law shall on conviction be liable to a fine or to imprisonment for a period not exceeding two years.

# 19. Enforcement of By-Laws

This by law will enforced by the Member of the Executive Council from the Liquor Board.
